

## Privacy Policy

Fit For Sport Limited is committed to protect the privacy of individuals who visit our website and who make use of the on-line facilities at to [www.fitforsport.co.uk](http://www.fitforsport.co.uk).

This Privacy Policy covers Fit For Sport's use of personal data collected from you when you use [www.fitforsport.co.uk](http://www.fitforsport.co.uk) or other registered domain names.

### 1. Data Controller

The Data Controller of this website is Fit For Sport Limited whose office is situated at Suite 3, Second Floor, Profile West, 950 Great West Road, Brentford TW8 9ES.

### 2. Personal Data collected from you and how it is processed

When using our website's online facilities, you may be required to provide personal data. Personal data in this Privacy Policy means information that specifically identifies you as an individual, or is capable of doing so. This includes but is not limited to a first and last name, a date of birth, a home address, an email address, or other contact information.

Personal data is collected from you when you register to use our services, make bookings, enter into any of our competitions or promotions, submit a customer review, apply for a job or enter into correspondence with us.

We use personal data collected from you for the following purposes:-

- To respond to an enquiry made by you
- To improve your online experience and to personalise your visits
- To improve our products and services and those of our suppliers
- To notify you of special offers and promotions
- To process your online bookings and any other transaction you make via our website
- To send you information that we think you may be interested in

When you visit our website, we also collect information automatically about your visits, such as browsing patterns. However information collected in this way is only used in aggregate and anonymous form rather than being linked to identifiable individuals

### 3. Cookies

When you visit our website, we may send you cookies. Cookies are small pieces of data that our site transfers to your computers' hard drive when you visit the website. A cookie will typically contain the name of the domain from which the cookie has come, the "lifetime" of the cookie and a value which usually is a randomly generated unique number. The following two types of cookies are used on our website:-

#### ***Session Cookies***

These are temporary cookies that remain in the cookie file of your browser until you leave our website. These allow you to carry information across the pages of our website and avoid you having to re-enter information.

### ***Third Party Cookies***

Third parties provide persistent cookies via our website. These are used to compile anonymous, aggregated statistics in order to serve advertisements on our website and track whether these advertisements are clicked on by users in order to control how often you are shown a particular advertisement. They also count the number of anonymous users of the website and provide security within transactions.

Our cookies cannot be used by themselves to identify you. You have the ability to accept or decline cookies by modifying the setting in your browser. However, you may not be able to use all of the interactive features of our website if the cookies are disabled. In any case if you consider that certain information about you is inaccurate, you may request rectification of such data. You also have the right to request the blocking or erasure of data which has been processed unlawfully.
